Illinois law permits municipalities to adopt by one single unanimous roll-call vote of the Board of Trustees and the Village President a group of designated ordinances, orders, resolutions, or motions placed together for voting purposes in a single group.

If lengthier discussion or debate is needed, any Trustee or the Village President may request any item to be removed from the motion and those items will be considered during the regular course of the meeting as they appear on the agenda.

All matters listed under Consent Agenda are considered to be routine by the Village Board and will be enacted by one motion in the form listed above. There will be no further discussion of these items. If discussion is desired, that item will be removed from Consent Agenda and will be considered separately.

B. DOERING LANDSCAPE PROPOSAL FOR MOWING AT VILLAGE HALL

<u>Summary:</u> The Village's contract with Doering for maintenance of the Village Hall grounds came to an end last year. They provided a two-year proposal for consideration.

<u>Recommended Actions:</u> Motion to approve an agreement with Doering Landscape Company in an amount not to exceed \$25,800 (for two years) and authorize the Village Administrator to execute the necessary documents.

C. ENGINEERING INSPECTION FOR IRON REMOVAL FILTER TANKS

<u>Summary</u>: The Village's two iron removal tanks need to be cleaned and repainted in order to provide optimal performance. This work needs inspections at critical points in the process to ensure the contractor is in compliance with the materials, means and methods of the work to ensure specifications are being met. Dixon Engineering and Inspection Services was chosen to compete the work.

Recommended Action: Motion to approve an agreement with Dixon Engineering for each of the two Iron Removal Filter Tanks in an amount not to exceed \$24,400 and authorize the Village Administrator to execute the necessary documents.

D. OLD BARRINGTON ROAD DESIGN ENGINEERING SERVICES

<u>Summary</u>: The reconstruction of Old Barrington Road using school impact fees was discussed last month at the budget presentation, and concurrence to move forward with engineering design was given.

Recommended Action: Motion to approve an agreement with HR Green, Inc., in an amount not to exceed \$15,467 and authorize the Village Administrator to execute the necessary documents.

E. MOSQUITO MANAGEMENT - CLARKE

<u>Summary:</u> Clarke has been providing mosquito management services to the Village for over 15 years. They have provided good service and have held their prices steady since 2011.

Recommended Action: Motion to approve an agreement with Clarke in an amount not to exceed \$25,000, and authorize the Village Administrator to execute the necessary documents.
